## Freedom of Information Act 2000 (FOIA)

Thank you for your request, which was received on 11 December, for the following information:

"The OTS published a review of VAT in 2017 - see <a href="https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment\_da\_ta/file/657213/Value\_added\_tax\_routes\_to\_simplification\_web.pdf">https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment\_da\_ta/file/657213/Value\_added\_tax\_routes\_to\_simplification\_web.pdf</a>

Chart 1 on page 7 of the report shows the number of entities by turnover band around the registration threshold, using HMRC data from 2014/15. I attach a copy of the chart for your ease of reference. The precise source isn't stated, but I am assuming this is from Income and Corporation Tax Self Assessment returns, not just VAT returns (because VAT returns would have only very limited data below the VAT registration threshold).

Could you please provide equivalent data for the most recent tax year that is available, i.e., a table showing the number of entities at different turnover bands, varying between say £10,000 and £150,000, going up in £500 bands."
